Vendors are encouraged to obtain liability insurance. The Landlord assumes no responsibility for any physical loss or damage at any time to the physical property of Vendors. In the event the Market is sued for any negligent act of a Vendor, the Market's insurance company will subrogate against said Vendor for full amount of any loss paid.

Vendor's payment and use of the Vendor Permit provided acknowledges that the vendor accepts and agrees to adhere to all of the terms and conditions set forth on the Vendor Permit and all Rules and Regulations appearing on **APPENDIX "A"** attached and the Westbank Flea Market website. The Westbank Flea Market reserves the right to revoke the Vendor Permit granted by the Market and to reasonably refuse service and/or booth rental to anyone, or to require any vendor to leave for violation of the Rules and Regulations. Westbank Flea Market reserves the right to formulate additional rules and regulations if necessary and each seller shall abide by such additional rules and regulations.
